NOTICE AND ORDER
(Issued July 2, 2001)

This matter is before the Commission upon the tariff filing of PacifiCorp (the Company) for authority to amend Schedule 2020 to include a 10% bill reduction to residential customers who achieve a 10% reduction in their energy use from the same billing month in the previous year.

The Commission, having reviewed the attached tariff, its files regarding PacifiCorp, applicable Wyoming utility law and otherwise being fully advised in the premises, FINDS and CONCLUDES:

1. PacifiCorp is a public utility as defined in W.S. § 37-1-101(a)(vi)(C) and, as such, is subject to the jurisdiction of this Commission pursuant to the provisions of W.S. § 37-2-112.

2. PacifiCorp filed a tariff to amend its Schedule 2020, the Customer Challenge program, to include a 10% bill reduction to residential customers who achieve a 10% reduction in their energy use from the same billing month in the previous year. The Company states that the program is intended to reduce peak power usage and will be offered for billings in the months of July, August, and September. Currently, the Company offers a 20% bill reduction to residential customers who achieve a 20% reduction in their energy use from the same billing month in the previous year.

3. The Commission finds and concludes that the amendment to Schedule 2020, the Customer Challenge program, to include a 10% bill reduction to residential customers who achieve a 10% reduction in their energy use from the same billing month in the previous year, reduces peak power usage, conforms to the Public Service Commission of Wyoming's Procedural Rules and Special Regulations, and is in the public interest.

4. PacifiCorp's application is on file with the Commission at its offices in Cheyenne, Wyoming, and may be inspected by any interested persons during regular business hours.

5. Anyone wishing to request a hearing, file a statement, representation or protest this application must do so on or before July 30, 2001.
